Hi everyone,

We have had a small business item come up recently.

I think we may just be able to approve this action via email, if we “reply all” on this thread.

Item:

Former ESFRS teacher Nicolette Garman has submitted invoices for teaching during April, May, and June 2023. These invoices were received in March 2024, after our fiscal year end of July 31, 2023.

I think that we should see if we can still pay these invoices (with adjustments, as outlined in the attached emails which give details).

Even though Nicolette has missed our year end for that year, she has had difficulty meeting commitments due to ongoing health issues (which is why she had to stop teaching).

Making this payment will require some adjustments to our budget forecast for this year.

There is funds to cover this payment in our reserve.

I propose that we send Nicolette a final teaching payment of \$2,449.89 to cover these invoices (which reflects adjustments discussed in attached correspondence).

Since this will involve changes to the budget originally approved by the Board, I would like to receive approval from you to do this.

Please “reply all” to this email with your response.

Once this payment has been made, Beth and I will have an administrative meeting to readjust the 2023-24 ESFRS budget to
